This newsletter is published bi-annually by the *Friends of Hart Mountain National Antelope Refuge* for the benefit of its members. Copies are also made available to visitors and through various other outlets in Lake County.

The *Friends of Hart Mountain National Antelope Refuge* is an independent, non-profit, 501(c)(3), corporation dedicated to supporting the primary purposes for which the Hart Mountain National Antelope Refuge was established: to provide habitat and breeding ground for pronghorn antelope and other species of wildlife; for the protection of natural resources; and the development of incidental wildlife-oriented recreation where it does not interfere with the primary purposes of the Refuge.

## In-holding Acquisition At Hart Mountain NAR by Ken Guza, President Friends of Hart Mountain

In December 2007 the *Friends of Hart Mountain* sent a letter to it's membership asking for donations that would be dedicated to acquiring private property in-holdings within or at the boundaries of the refuge. This fund raising effort has generated almost \$3,700.

I am proud to announce that these funds will be used in the next few months for the first acquisition project involving the *Friends*. A forty acre parcel, within the refuge boundary, is available for purchase from a willing seller. The property has been appraised and there is a preliminary agreement with the owners to sell the property to the Fish and Wildlife Service (FWS) for \$10,000. The Board of Directors for the *Friends of Hart Mountain* has approved use of \$3,500 toward this purchase. The availability of the *Friends* funds created an opportunity for matching funds of \$3,500 from a private foundation. The remaining \$3,000 will be provided by FWS. FWS real estate office staff are currently working with the owners on details of the sale.

We are very excited at this development. We can take credit as an organization for promoting the idea of acquiring in-holding properties at the refuge and making funds available to start that process. Our role in organizing a meeting last spring with a dozen potential partner organizations helped to get the acquisition project moving forward.

There are nearly 6,000 acres of in-

holdings so the funds to acquire in-holdings are a major undertaking, well beyond the capacity of the *Friends of Hart Mountain* alone. Acquisition of in-holdings will be a multi year project that is dependent on willing sellers and availability of major funding. To this end the *Friends of Hart Mountain* are proposing a meeting with potential partner organization such as The Nature Conservancy, Oregon Natural Desert Association and other groups to consider long-term funding strategies.

Purchase of in-holding properties, as they become available, requires access to a pool of funds that can be used over a period of years. To conserve and protect such properties, timing is often the critical factor. The availability of a property generally is not predicable and the window of opportunity for purchase may be time limited. The capacity to act quickly on a purchase opportunity is critical.

While major funding is needed, the funds we raised allowed us to leverage additional funds for the project noted above. It is important that the *Friends of Hart Mountain* continue to raise funds dedicated to acquisition. If we repeat the past fund raising success we are positioned to help with purchase of the next project or to provide match for grant applications.

## MESSAGE FROM THE MANAGER By Rob Bundy

**Project Progress on Hart Mountain**  
Hi Everybody. Looks like we are just getting to that time of year when our management operations go into “hibernation,” so to speak. This gives us an opportunity to catch our breath, reflect on the projects that we completed over the past year, and start planning out projects for the coming field season. Even with our reduced staff, the *Friends of Hart Mountain* and numerous volunteer’s helped us accomplish a large number of projects; many more than we would have been able to finish alone. Examples that come to mind include the CCC Camp fence, interior fence removal along the south boundary, compilation of before/after grazing photos, land acquisition (to be discussed in more detail later), as well as visitor center staffing and the routine maintenance activities that keep Hart Mountain operating through the spring, summer, and fall. Without these important contributions, we would not be able to complete our projects so please accept my sincere thanks for everything that you do.

Now, here are some of the things we have been able to accomplish because of your support.

**French Glenn Road Improvement**  
After nearly 10 years of planning, the French Glenn Road Project is finally complete. This project resurfaced approximately 31 miles of refuge road from the base of the grade, all the way to our eastern boundary. For those of you who were on Hart Mountain this summer, you likely noticed a bit more truck traffic than you were used to, and something I don’t believe any of us ever expected: “flag persons on Hart Mountain.” There were definitely some short term inconveniences; however, the long term benefits are already apparent. There should be considerably less need for road maintenance and a much smoother ride next time you visit. The project ran fairly smooth after a few early “false starts” and wish I thank everyone for their extreme patience during this process.

### Hart Mountain Shop

This is another project that moved fairly slowly over the past few years; however with our rehiring of Jack Elizarraras, we were able to close this one out. The project provides the final interior office/storage improvements and allows our personnel to move into a more modern office space. This should allow us to consider other options for the old shop space, including the potential to develop additional visitor facilities.

### Telecommunication Improvement

As many of you are already aware, Hart Mountain has had exceptionally inconsistent internet availability over the past several years which is largely the result of a poor satellite connection. We did, however, have fiber optic cable installed in the late 1990’s to ensure a consistent phone connection, which now allows us to bring DSL Internet Service to Hart Mountain. The line has been run from Lakeview to the McKee Ranch and we are waiting for two signal boosters to ensure adequate signal strength to our HQ. We should have this Service available by spring.

### Boundary Fencing

Many partners including the *Friends of Hart Mountain*, have come to our aid to remove interior fencing on the refuge. In the past, this fencing was used to support livestock grazing, but since removal of cattle in 1994, the fencing has become an entanglement hazard and a barrier to pronghorn antelope and other native wildlife species movements. More recently, we have discovered that our boundary fencing, or more specifically, a lack thereof, has become a much larger concern. There are about eight miles along the SE boundary and 5-6 miles on the SW boundary that remain unfenced. This allows free movement of neighboring livestock, but more commonly now, feral horses from nearby BLM lands. The population has been modulating the last few years and we do have an agreement in place with BLM to remove any horses from Hart Mountain NAR. Unfortunately, it really does not

do much good to remove horses if they immediately return through an unfenced boundary.

Over the past year, the refuge has acquired enough material to construct two miles of boundary fence and has been discussing partnership opportunities with the Oregon Hunters Association and the Order of the Antelope to obtain further material and personnel to construct the fence. If we can continue to work together, I believe we can get most of the SE boundary fenced within the next three years. This will minimize the trespass threat from the adjacent Beatty’s Butte Horse Management Area, but will not entirely solve the SW corner fencing problem. There are some land acquisitions and/or conservation agreements that still must be enacted before fence can be erected in this area; however, the *Friends of Hart Mountain* In-holding Acquisition Program has been influential in identifying key parcels and helping the Service to develop the appropriate conservation strategy.

### Outdoor Education Pavilion

Another key project we are currently exploring is the construction of an education pavilion at the new CCC Camp. The Oregon Hunters Association (OHA) proposed the project last spring and we are now working with OHA’s architect to develop floor plans to meet a late spring construction window. This is one of the few locations on Hart Mountain where there is power and water making this an ideal site to accommodate large school groups, agencies, or organizational meetings. Additionally, it would make the CCC Camp considerably more attractive to campers which would help to alleviate competition for camp sites during key periods.

We will again be short staffed and busy through the 2009 season, but as has been the case over the past several years, if we continue to work together, we can continue to accomplish great projects for wildlife and the public. Thank You for your continued help and support through this tough period.

## Hart Mountain Mule Deer Count

On Monday, Nov. 17, 2008, 14 staff and volunteers drove and hiked across Hart Mountain on a windy, but sunny day, and counted 173 mule deer: 85 does, 59 fawns, 22 bucks, and 7 of undetermined age and sex. From 2004 to 2007, count numbers dropped steadily from 376 to 165. Let's hope that 2008 marks an upturn. Fawn to doe ratios were exceptionally high this year, at 69 fawns per 100 does, compared to 20 fawns per 100 does in 2007. The fall mule deer count has occurred for 41 years, since 1967. In only 16 of those years has the fawn to doe ratio been as high. Twenty-six bucks to 100 does were counted this year--about average. One hundred sixty-nine miles were driven or hiked; approximately 1 deer per mile was seen. Thank you to everyone who helped make this survey a success.

## FENCE REMOVAL 2008

Volunteers and staff at Hart Mountain NAR have been working on the continuing project of removing all unnecessary fencing from the refuge. Originally the fences were needed for the containment of the livestock on the refuge. Now, since the livestock has been removed from the refuge, we are working to remove the fences that are not needed. When the project began, there were approximately 213 miles of unnecessary fence on the refuge. During the past 15 years, volunteers and staff have removed about 205 miles of fence, which leaves about 8 miles of fencing remaining to be removed. In July 2008, Oregon Natural Desert Association (ONDA) removed 2.84 miles of unnecessary fence. We would like to thank ONDA for their help with this worth-while service project. We also want to thank **Friends of Hart Mountain** volunteers George Reynolds and Morrie Chappel for their leadership and support to make it happen.

## Biology Update

Another successful field season on Hart Mountain is behind us as the winter snows begin. Here is a brief summary of some of the biological activities completed this year:

**Pronghorn survey:** In July 2008, we completed our annual summer aerial survey for pronghorn; surveys using a variety of methods have been conducted for pronghorn on Hart Mountain since the mid-1950s. The data collected is similar to that for bighorn: minimum population estimate, sex and age ratios, and general population trend. These surveys are not intended to be a complete census, but to give us a general sense of the population trend. This year we observed a total of 2,024 pronghorn with herd ratios of 47 bucks:100 does and 47 fawns:100 does. The 10-year average trend indicates an increasing population (+10.8%) since 1998. During this effort, we also documented a total of 101 feral horses and 6 trespass cattle.

**California bighorn sheep survey:** We completed our annual summer bighorn sheep helicopter survey in July 2008; surveys for bighorn sheep have been conducted on Hart Mountain since their reintroduction in the mid-1950s. This survey provides us with a minimum estimate of the bighorn population, sex and age ratios, and general population trend. These surveys are not intended to be a complete census, but to give us an idea of the general status of the population. This year we observed a total of 212 sheep, with herd ratios of 55 rams:100 ewes and 43 lambs:100 ewes; both the highest values observed since 2005.

**West Nile Virus monitoring:** This project was initiated in 2005 in cooperation with the National Wildlife Health Center, and in 2008, blood samples were taken from sage-grouse and songbirds to monitor the spread of the disease. To date, no samples from Hart Mountain have tested positive for the virus.

**Greater sage-grouse lek counts:** Each year, volunteers and refuge staff conduct sage-grouse lek counts on Hart Mountain Refuge and the data is used to monitor population trends. It appears that the ongoing decline in overall sage-grouse numbers continued in 2008, however production was improved.

**Greater sage-grouse translocation:** We continue to support translocation efforts for sage-grouse as part of augmentation or reintroduction efforts across the western states. During 2008, a total of 40 birds were trapped from Hart Mountain and released as part of a reintroduction program in Washington.

**Songbird banding:** Songbirds have been banded on Hart Mountain annually since 1989. In 2008, 543 birds were banded and released.

**Raptor nest occupancy surveys:** Raptor nesting areas have been documented on Hart Mountain Refuge since 1937 and continued annually until the early 1990s. Surveys were re-initiated in 2008 to revisit historic nest sites and document use.

**Invasive plant surveys and treatment:** In 2008, the Oregon Department of Agriculture spot-treated approximately 6,000 acres on Hart Mountain for noxious weeds.

**Effects of habitat treatments in low sagebrush:** This ongoing project is in coordination with the Joint Fire Science Program. Hart Mountain is part of a large, regional research experiment to evaluate the effects of prescribed fire and other habitat treatments in the sagebrush ecosystem.

**Effects of habitat treatments in mountain sagebrush:** This project is in coordination with the Oregon Agricultural Research Station. The purpose of this research experiment is to evaluate the response of under-story vegetation to a variety of habitat treatments.

### A. Manager's Update - Rob

- Road improvements Progress
- Shop Project Completed
- Internet Access - the satellite hook-up will be replaced with DSL in 2009 or maybe later this year. The line will benefit the local community.
- Fencing materials - End of fiscal year funds were used to purchase 2 miles of fencing materials. 14 miles of fencing is needed to complete the boundary fence. Oregon Hunters Association and Order of the Antelope will participate in putting in the fence. There may be funds from the maintenance budget to purchase materials for 8 more miles.

### B. In-holdings - Rob & Ken

We are moving forward with purchase of the Oberbillig property, 40 acres east of Post Meadows. The Fish and Wildlife Service (FWS) staff are working with the Oberbillig estate with the goal of completing a purchase and sale agreement as soon as possible. An appraisal is completed which supports the agreed price of \$10,000. It is proposed that \$3,500 would come from the Friend's acquisition fund, \$3,500 match from a private foundation, and the remaining \$3,000 from FWS funds.

Motion: Move approval of \$3,500 from the **Friends of Hart Mountain** acquisition fund to be used for this purchase.

Morrie asked that he be sent materials for a Winter Newsletter. Ken will write-up in-holdings, Rob will cover the topics in his manager's update. Marla will be asked if there are items she would like to include.

### F. Marla Bennett - Refuge update (by fax and read by Rob)

Marla has been in contact with a graphic designer who is willing to work on improvements (photos/graphics) to the **Friends** brochures. Marla sug-

gested the petroglyphs, natural history, geology and homestead. Amy has been in contact with John Griffin who is the historian for the Order of Antelope. He plans to have a draft in January, 2009, from which we could draw HMNAR appropriate material.

Marla would also like to see the creation of a library accessible to the public at Headquarters.

### G. Homestead identification/ protection - Diana

Diana and Marla have been in contact with LouAnn Speulda-Drews, FWS Reno, NV office, She plans a visit to HMNAR the week of April 20 - 24, 2009. We will try to get to several homestead sites, but specifically will want to take a look at the Flook Ranch. LouAnn has access to funds that can be used for preservation and has a volunteer with carpentry skills who can oversee preservation work. It is possible we will be able to do some stabilization work in April.

### H. Federal Highway Administration (FHA) - Rob

There maybe funding for road improvements from CCC camp to HQ. If they become available, a portion of those funds could be used for visitor facilities.

### 2008 HUNTING SUMMARY

All hunters were successful in the 2008 Antelope Bow and Antelope Rifle hunts, removing 49 pronghorn bucks from the herd. All 4 bighorn sheep hunters were successful; 1 hunter with a sheep tag did not show. Eight of 19 hunters harvested animals in the Mule Deer Muzzleloader season. The Mule Deer Bow seasons were separated into 3 hunts this year. Eight hunters out of 35 were successful in the early bow seasons. The late bow season was new this year, and ran from November 1-7. Nine hunters attended the hunt, but none were successful.

## Volunteers Needed

**1. Invasive Species Control.** June – August - Hart Mountain NAR is beginning a noxious weed management program. We need volunteers to identify weeds and spray or dig them out. You will get to hike our meadows, canyons, and riparian areas to document the locations of noxious weeds. We will train you.

**2. Maintain Facilities.** May – October Paint, clean, odd jobs. Volunteers are needed for a variety of tasks: make and replace signs, pick up litter, building renovation/repairs (skilled carpenters), and painting.

**3. Public Relations.** May – October People-oriented volunteers who would like to greet visitors and hunters and answer questions. Creative people who can help us revise/update our Visitor's Center displays.

**4. Office Work.** Anytime - There are always office duties such as filing, organizing, writing, printing and folding brochures, and stocking the visitor's center.

**5. Hot Springs Campground Host.** May to November - We are looking for

volunteers with RV's who can commit a month or longer, but the time can be negotiable. The campground host interacts with campers, answers questions, gives directions, helps keep out-houses cleaned and stocked, and generally oversees campground activities.

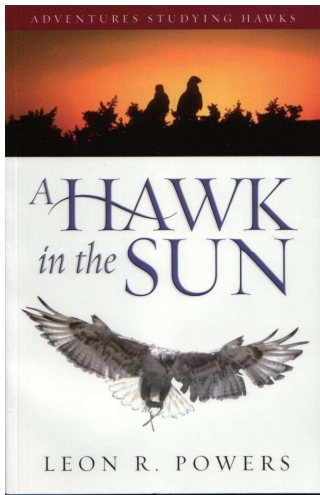
**6. Build a Fence.** May through October - This summer we plan to enclose the historic Civilian Conservation Corps (CCC) camp on Warner Lakes. In addition we always need to do maintenance on existing fences. Call the Refuge office to volunteer.

## Special Events at Hart Mountain

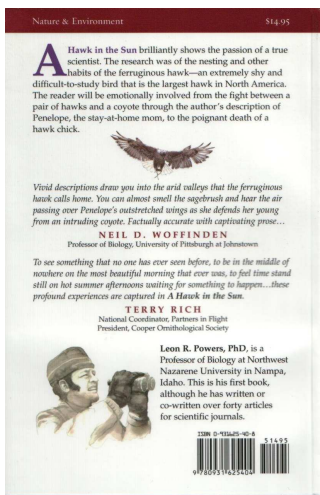

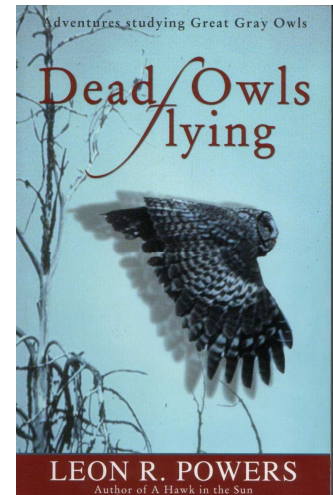
## BOOKS FOR SALE

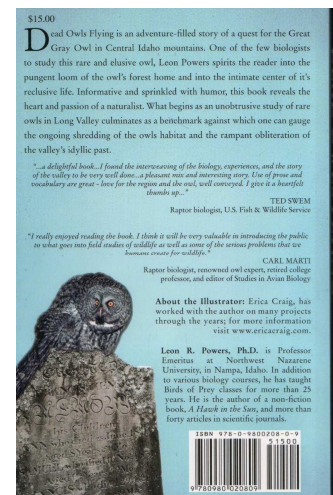

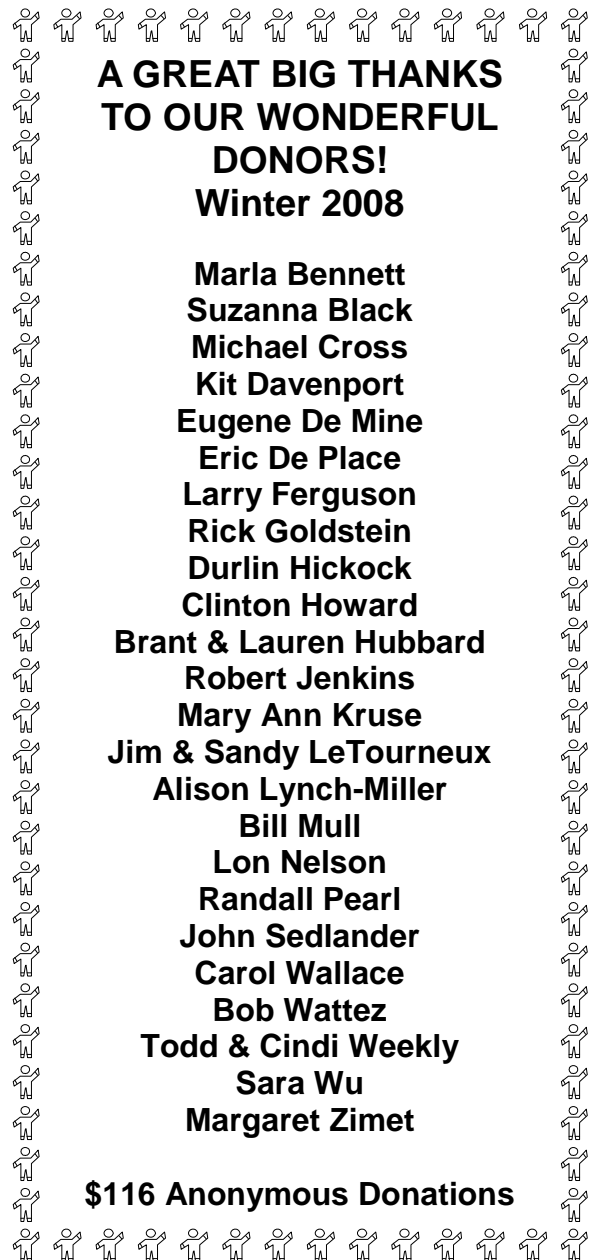
